#### DIRECTIONS FOR USE:

**FOR COUNTERACTING AIRBORNE ODORS** – Utilizing a trigger sprayer or pump-up sprayer discharge into the air the appropriate amount of formula allowing up to 5 to 20 seconds for the fresh scent to counteract unwanted odors. Apply only to empty room. Do not spray where food may be contacted.

**FOR FABRIC TREATMENT** – Discharge appropriate amount of product to fabric, upholstery, curtains, etc., insuring that spray device is held approximately 10 to 15 inches away from treated surface. Apply product evenly to affected area. Do not overwet.

**GUEST ACCOMMODATIONS** – Apply proper amount of product approximately 5 inches above carpet level to entire perimeter of room or until odor is eliminated.
